1. a) Write the set of all vowels in the English alphabets which precede q.
b) Let $U = \{1, 2, 3, 4, 5, 6, 7, 8, 9\}$ $A = \{2, 4, 6, 8\}$ and $B = \{2, 3, 5, 7\}$. Verify that $(A \cup B)' = A' \cap B'$.
2. a) Define Tautology with example.
b) Define diagonal matrix with example.
3. a) Find the symmetric difference of two set A and B where $A = \{1, 2, 3, 4\}$ $B = \{2, 3, 5\}$.
b) In a group of people, 50 speak both English and Hindi and 30 speak English but not Hindi. All the people speak at least one of the two languages. How many people speak English?
4. a) Show that the statement $(p \wedge \sim q) \wedge (\sim p \wedge q)$ is a contradiction.
b) Prove that $p \rightarrow q \equiv (p \rightarrow q) \wedge (q \rightarrow p)$.
5. If $A = \begin{bmatrix} 1 & 2 & 1 \\ 0 & 1 & -1 \\ 3 & -1 & 1 \end{bmatrix}$ Show that $A^3 - 3A^2 - A + 9I = 0$.
6. a) Solve the equation $1 + 6 + 11 + 1 + 6 + \dots + x = 148$.
b) How many terms of the sequence 18, 16, 14, ... should be taken so that the sum is zero?
7. a) How many terms of the G.P $3, 3^2, 3^3, \dots$ are needed to give the sum 120?
b) Which terms of the G.P $2, 2\sqrt{2}, 4, \dots$ is 128?

8. a) Let $A = \begin{bmatrix} 1 & 2 \\ 4 & 3 \end{bmatrix}$ $B = \begin{bmatrix} 2 & 0 & -4 \\ 3 & -2 & 6 \end{bmatrix}$. Find AB , BA .

b) Find x such that $\begin{bmatrix} 1 & x & 1 \end{bmatrix} \begin{bmatrix} 1 & 2 & 3 \\ 4 & 5 & 6 \\ 3 & 2 & 5 \end{bmatrix} \begin{bmatrix} 1 & -2 & 3 \end{bmatrix} = 0$.
